DISTRICT MONITORS IMPACT OF PROPOSED STATE BUDGET Projections Estimate Cuts of Ten Percent to Current Funding

Governor John Kasich released his first two-year biennium budget in mid-March, providing school districts across the state with the information they have been waiting for to confirm how their financial forecasts of anticipated cuts match up with reality. Since last spring, school districts have been advised to brace for cuts in their state funding of up to 30 percent. Olmsted Falls City Schools, and many surrounding districts, have been budgeting for a cut of 10 percent in the five-year forecasts.

While it will take time to determine the exact impact on our District, a preliminary review of the cuts seem to reveal that District projections (of 10%) are relatively close to actual. In early April, the Ohio Department of Education released a spreadsheet detailing the specific financial impact of the Governor's proposed biennium budget on local school districts across Ohio. The box at the right features the breakdown provided for Olmsted Falls School District.

It is important to note that these figures are simply estimates that were generated from the Governor's proposed budget. As this legislation moves through the Ohio Legislature, things will almost assuredly change. However, the general trend points strongly to a future with fewer state dollars flowing to Olmsted Falls Schools. It is clear that the Olmsted Falls School District will have to continue to operate in an arena of decreasing budgets. Passage of the 2.8 Mill P.I. Levy on May 3, 2011 will be critical to helping our District stretch existing dollars and have the funds available to address facility maintenance issues.

2.8 MILL P.I. LEVY OFFERS MULTIPLE BENEFITS FOR TAXPAYERS WITHOUT INCREASING CURRENT TAX LEVEL

Since January, the Olmsted Falls School District has been working to educate the community about the 2.8 Mill P.I. Levy that has been placed before voters on the May 3rd election ballot. **While the ballot language must classify this levy as "additional" because it is a new P.I. Levy, the corresponding timing of a scheduled reduction of 2.8 mills of existing bond millage will result in no increase to the current school tax level for residents.**

Proceeds from the passage of the 2.8 Mill P.I. Levy would provide a dedicated funding stream for permanent improvement projects and purchases (with a useful life of five years or more), **and help lengthen the span of time before the next operating levy is needed.** This revenue stream would help protect the community's long-standing investment in its school facilities by providing funds needed to adequately handle pressing renovations needed at older facilities. For example, parts of the plumbing and electrical systems at Olmsted Falls High School are

original to the 42-year-old building. Having this dedicated revenue stream will be critical to completing projects, such as electrical and plumbing systems upgrades/renovations at the High School, without having to tap into already stretched general fund dollars.

With the cuts to education at the state level now becoming more clear (see lead cover story), passage of the 2.8 Mill P.I. Levy on May 3rd is even more critical to the financial stability of the Olmsted Falls School District.

"By placing this P.I. Levy on the ballot in the same amount (2.8 mills) as the scheduled debt retirement, we are asking our community to maintain their current level of support," says Board of Education President Mr. Frank Pedicini. "These funds will be critical to supporting much-needed building maintenance projects and to increasing the length of time before the next operating levy is needed."

Following the passage of the operating levy in February 2010 - the District's first operating levy in 11 years - the Board of Education pledged no new operating levy for a minimum of three years.

Passage of the 2.8 Mill P.I. Levy on May 3rd will extend the length of time before the next operating levy beyond that original three year projection - without increasing the current level of school taxes.

If the 2.8 Mill P.I. Levy does not pass, District residents would experience a reduction in their school taxes of about \$80 per \$100,000 in home property value annually effective January 1, 2012.

2.8 MILL P.I. FACTS-AT-A-GLANCE

- **WILL NOT INCREASE CURRENT LEVEL OF SCHOOL TAXES**

While the ballot language must classify this levy as "additional" because it is a new P.I. Levy, the timing of the corresponding reduction of 2.8 mills of existing bond millage will result in **no increase to the current school tax level.**
