# **DID YOU KNOW?**

It may come as no surprise that fuel prices have taken a toll on transportation costs in our District. We experienced an increase of approximately 34.5% over budgeted costs due to the uncontrollable increase in gasoline/diesel prices. Energy costs at all six District buildings are on budget as we get ready to close out the 2007-08 fiscal year.

# County Residential Property Tax Rates for 2007

The chart below details tax rates for all cities within Cuyahoga County and includes the effective tax rate adjusted for House Bill 920 (HB920 freezes most school millage to dollar level when levy passed) and other automatic rollbacks. # On The Move: Overview of District Transportation Operations

Every school day, the Olmsted Falls School District Transportation Department transports approximately 3,185 students. A staff of 32 full-time bus drivers, five substitute drivers, and one transportation aid, log 1,737 miles on our 34 active buses each school day. Annually, Olmsted Falls school buses travel more than 341,200 miles, when travel to and from athletic events and field trips are added to the equation!

While the majority of students are transported each day to one of the four Olmsted Falls School District buildings, many are transported to local private, parochial and special education schools – as required by law. A total of 27 schools are serviced throughout Northeast Ohio. In addition to our fleet of school buses, the District also utilizes the services of private cab companies, as

needed, for the specialized transport of special needs students.

In order to maintain the safety of both drivers and students, drivers must adhere to specific routes and designated bus stops. The Olmsted Falls Transportation Department employs one manager, Al Cantrell, and one secretary, Jan Holecko, who set and coordinate bus routes annually along with other daily duties which keep the department running smoothly and efficiently.

Drivers attend monthly staff meetings and are involved in continuing safety education. Every driver is re-certified every six years, which involves taking classes, a written test and an on-bus test through the Ohio Department of Education. Bus drivers perform pre-trip vehicle inspections each morning and afternoon, checking the bus internally and externally for potential problems.

"Our drivers are doing an excellent job of transporting Olmsted Falls' students safely," said Tim Atkinson, Director of Business Affairs for Olmsted Falls Schools. Mr. Atkinson has been at the helm of the Olmsted Falls Transportation Department since 1978. (In 1999, he was named Director of Business Affairs and expanded his responsibilities to also include building and grounds maintenance.)

At the District's bus garage, located on Schady Road, two mechanics work daily to keep the District's fleet of buses in top working condition. Our maintenance crew has a 100% passage rate on all buses through the Ohio Highway Patrol's annual inspection program. The maintenance staff also maintains the District's 17 maintenance vehicles. In addition, the Olmsted Falls Transportation

Department provides maintenance and/or fueling services for vehicle fleets from the City of Olmsted Falls and Olmsted Township, as well as buses from Lakewood City School District, helping to generate additional revenue for the District.
