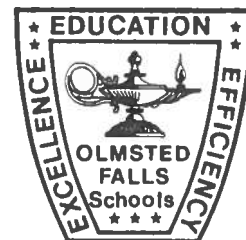

Dear Parents of Eighth Grade Students:

The eighth grade class will be going to Cedar Point on Friday, May 29, 2015. Students will depart OFMS at 8:30 AM and will return to OFMS by 8:00 PM. This trip is a reward trip for the students' hard work in the areas of academics and behavior.

Unfortunately, not all students will qualify to participate in the field trip. Students that earn five (5) points from April 8 through May 29 on our discipline system or whose behavior and academic efforts do not meet expectations will not be allowed to attend. Those students who remain at the middle school on May 29 will be given a variety of activities to complete.

Students will not be permitted to ride any of the water rides and **should not** bring bathing suits. **Students are permitted to bring their cell phones on this trip.** We would like the student's cell phone numbers in the event we would need to contact them during the day while at Cedar Point.

Please see the attached permission sheet for details. Please sign and have your child return the permission slip form and payment (cash or check) **during 8th grade lunch in the Cafetorium during the week of May 18-22, 2015. Payment must be received no later than May 22, 2015.** The cost of the trip will be **\$38.00** for the park admission. **All students must bring money to purchase their own food at the park.**

If a student has a season pass to Cedar Point, then he/she does not need to pay the \$38.00. The student must turn in the signed permission slip during the week of May 18 -22 at lunch and show the season pass to the person who is collecting money.
