MAY BALLOT ISSUE PROVIDES OPPORTUNITY TO CONTINUE INVESTMENT IN SCHOOL FACILITIES

2.8 MILL PERMANENT IMPROVEMENT LEVY WILL NOT RAISE TAXES

Tuesday, April 19th at 7:00 p.m. Olmsted Fall High School Library Media Center At their regular monthly meeting, held January 19, 2011, members of the Olmsted Falls Board of Education voted 5-0 in favor of placing a 2.8 Mill Permanent Improvement Levy on the May 3, 2011 election ballot. This Permanent Improvement Levy WILL NOT INCREASE TAXES paid by residents of the Olmsted Falls School District community, but will provide for a dedicated funding stream for permanent improvements and facilities upkeep. The vote to place this issue on the ballot came following a lengthy series of strategic discussions among the Board of Education, District administration, staff, and community members, which began last summer.

While the overall strategic discussions focused on District needs one year, five years and ten years from now, discussions in recent months have centered around 2.8 mills of existing millage set to expire (or "drop-off") in calendar year 2012. Specifically, the 2.8 mills scheduled to expire in 2012 are part of existing bond millage that was approved decades ago by the community to expand and maintain District facilities. As of January 1, 2012, those 2.8 mills from the previous bond millage will be paid off in full. Without a vote by the community, these 2.8 mills would automatically "drop-off" the District's tax

rolls in 2012. This "drop-off" would result in a tax reduction for property owners of approximately \$80 per \$100,000 of property value.

"We felt it was important to bring this issue to the voters and let them decide if they want to continue supporting their long-standing investment in our local school facilities," said Mr. Frank Pedicini, President of the Olmsted Falls Board of Education. "Placing a Permanent Improvement Levy on the May 2011 ballot in the same amount as the "drop-off" of 2.8 mills provides our community the opportunity to redirect funds toward specific facility and equipment needs without increasing their taxes."

PERMANENT IMPROVEMENT (P.I.) LEVY QUESTIONS & ANSWERS

Q: How Much Will The 2.8 P.I. Levy Generate?

If passed, the 2.8 Mill Permanent Improvement Levy would generate \$1.4 million annually, which can be used by the District for permanent improvement projects and purchases. Permanent Improvement Levy funds must be spent on facilities, maintenance, equipment or materials that have a shelf life of 5 years or longer.

The ability to handle looming maintenance expenses in older District facilities with P.I. funds (as opposed to using District general fund dollars) can also help lengthen the time before the next operating levy is needed. With the passage of the last operating levy in February 2010, the District pledged no new operating levy for a minimum of three years.

Q: How Would These P.I. Funds Be Spent?


The most urgent facility needs that would be addressed with these Permanent Improvement funds are at the High School. Just like a home that is 42 years old, the Olmsted Falls High School building has a number of issues that must soon be addressed. (Olmsted Falls High School first opened its doors to students in the middle of the 1968-1969 school year.)

Even with the ongoing and proactive maintenance care of this building by the District's outstanding custodial staff, there are significant improvements that need to be taken care of including **roof replacement**, **electrical system upgrades** and **plumbing system pipe replacement**.

Q: How Will Passage Of The 2.8 Mill P.I. Levy Benefit the Community?

A dedicated revenue stream dedicated solely to permanent improvement projects and purchases will help provide the District the funds necessary to complete needed repairs in the most efficient manner. This not only protects the community's investment in existing facilities, but also saves money in the long run by resolving general maintenance and upkeep issues early before they become more expensive problems.

Q: Can P.I. Levy Funds Be Used to Pay Employees?

No. Funds generated from a Permanent Improvement Levy CANNOT be used to pay District operating expenses such as salaries and benefits. By law, no money from this revenue source could ever be used to pay employee salaries or benefits.

ON-LINE SURVEY OF DISTRICT PARENTS PROVIDES VALUABLE INFORMATION

The Olmsted Falls School District recently conducted an on-line survey of Bulldog parents to gather their thoughts and opinions regarding the educational programming and operation of the District. More than 600 parents completed the 12-question survey, which was conducted using an on-line survey tool called Survey Monkey.

The District was incredibly humbled to have had more than 90% of parents who participated in this survey rate our District as either "above average" or "best in the area." This is a testament to the daily commitment of our staff, our dedicated students and their supportive families in the Olmsted community.

While there were specific areas of concern, by some parents, the overall results of the survey show that parents in the community are generally pleased with our school system. A desire to see improvements made to the High School facility was a common theme throughout survey responses.

In addition to helping the District focus in on areas of needed improvement, the parent survey responses also revealed several instances of misinformation which have surfaced. A number of people have asked what we plan to do about this issue of misinformation out there. From a broad standpoint, we are looking for trends in the misinformation so that future communication efforts can be structured in a way to better prevent these misconceptions from occurring.

OFHS WRESTLING COACH BILL MCGRAIN RECORDS 300TH VICTORY

Congratulations to OFHS Head Wrestling Coach Bill McGrain on recording his 300th victory on December 4th over Eaton High School at the Findlay Duals. McGrain is in his 29th year as head wrestling coach, 26th year here at Olmsted Falls. Along with his 300 victories, McGrain has won thirteen Southwestern Conference titles, has coached seventy—four Southwestern Conference Champions, forty-four State Place Winners and seven State Champions. Coach McGrain has been selected by his peers as the Southwestern Conference Coach of the Year twelve times. He is a three-time Greater Cleveland Coach of the Year and has twice been selected as The Cleveland Plain Dealer Coach of the Year.

His most notable accomplishment, McGrain was inducted into the Ohio Wrestling Hall of Fame in 2006. 


PARTNERSHIP WITH POLARIS AND "PROJECT LEAD THE WAY" EXPANDS HIGH SCHOOL CURRICULUM AT NO COST TO DISTRICT

Always seeking new ways to stretch limited financial resources, the Olmsted Falls School District was able to expand upon its partnership with Polaris Career Center this year to add new engineering courses to the Olmsted Falls High School curriculum. The new pre-engineering courses are part of the "Pathway to Engineering" program and are designed to help high school students make an informed choice about their future by exposing them to concepts and courses necessary to be successful in the field of engineering. The curriculum is provided by Project Lead the Way (PLTW), an organization devoted to preparing students to be innovative and productive leaders in the fields of Science, Technology, Engineering and Mathematics.

Students not only receive high school credit for PLTW courses, but also have the opportunity to receive college credit by passing the final exams. There are four classes in the new "Pathway to Engineering" curriculum: Introduction to Engineering Design, Principals of Engineering, Digital Electronics, and Engineering Design and Development.

All Project Lead the Way Courses are taught on-site at Olmsted Falls High School utilizing teachers funded entirely through Polaris Career Center. There are currently 40 Olmsted Falls High School students enrolled in two sections of the introductory engineering course being taught by Mr. Mike Haydn. The hands-on, interactive nature



of the Introduction to Engineering Design course has received many positive reviews to date.

"Pathway to Engineering" is the second set of course offerings to be introduced at Olmsted Falls High School in partnership with Polaris Career Center and Project Lead the Way. Last year, a "Biomedical Sciences Program" was launched through the partnership. Now in its second year, there are 55 students currently enrolled in "Biomedical Sciences Program" courses.

Both PLTW programs offer four courses each, with each course building upon the next. Entering either the "Pathway to Engineering" or "Biomedical Sciences" programs in their freshman year allows students the opportunity to complete all four courses in their selected program. It is possible for sophomores, juniors and seniors to enroll in these specialized courses as well.

OLMSTED FALLS SCHOOL DISTRICT RECEIVES CLEAN AUDIT REPORT

Olmsted Falls School District is required by state law to undergo an independent audit of its finances each year. For the fiscal year ended June 30, 2010, Olmsted Falls School District was independently audited by Alger & Associates, LLC.
