Report from the Board of Education Regular Meeting of July 19, 2007.

1. **Administrative Reports**

- A. Mr. Weber gave an overview of the monthly financials; gave a report on the updated five-year forecast; reported on the resolutions shown below authorizing the sale of bonds in late August/early September 2007 for our new intermediate school construction; and reviewed a purchase order requiring Board approval because it was greater than or equaled \$3,000.00 and exceeded 10% of the original obligation (it was for Ohio Bus Sales for emergency repair of a school bus door).
- B. Mr. Lewis reported that the new teacher orientation was held on Tuesday, July 17 and Thursday, July 19 at the High School (as of this date 17 new teachers for the 2007-2008 school year have been hired); reported that the Family Consumer Science position at the High School is currently being recommended; and that interviews were held this week to fill a secretary position at Fitch School.
- C. <u>Mrs. Rami</u> report included the Ohio Achievement Test results for grades 3, 4, 5, 6, 7, and 8; and reported that the staff professional development workshops and mentor training sessions have been scheduled.
- D. <u>Mr. Atkinson</u> <u>Transportation:</u> report included: that another State Highway Patrol safety inspection of our buses will occur on July 25; that route modifications have been made due to construction projects throughout the District; that student bus information cards will be distributed by mid-August; and that he will be recommending the purchase of buses at a future meeting; <u>Buildings and Grounds:</u> we are securing a professional land appraisal for property west of our Board office; driveway, parking lot and sidewalk repairs, and other renovations are underway throughout District; that we tallied our building rental usage of outside groups during the 2006-2007 school year with a total of 2,304 "outside" uses by a wide range of groups; <u>Personnel;</u> hired a new bus driver from our substitute ranks; and reported that our summer staff is plugging away at all remaining projects in order to ensure a smooth start to the 2007-2008 school year.
- E. <u>Dr. Hoadley</u> reported on: our liability coverage through SORSA; an agreement with the Ohio Schools Council for cooperative purchasing for the 2007-2008 school year; an agreement with the County for our Positive Education Program; and the construction agreement with the Olmsted Falls Kiwanis Club; and gave a construction update on our new intermediate building.
